



# Cambridge Road Estate Construction Update – November 2022



We are pleased to update you in this newsletter on the progress of the regeneration of the Cambridge Road Estate

This newsletter provides you with an update on the on-site activities that will begin to take place in the coming weeks.

#### **Construction** Update


Since Planning Permission was granted to allow Phase 1 of the exciting regeneration of the Estate to commence, the site at Tadlow has been vacated. This is the first area of Phase 1 to be constructed and you will have noticed that the site area has now been secured with a timber hoarding. This is all in preparation for the demolition of the existing building and the new build works.

Before Tadlow block is demolished, asbestos will be removed from the building under controlled conditions by a specialist licenced contractor. The next stage involves the removal of all non-structural elements from the building – these will be recycled off-site.

Once this work is complete, the demolition of the block will be completed using long-reach machines with crushing jaws similar to the image shown on the right.

In addition to the timber hoarding, a protective scaffold screen will be erected between the site and the properties to the western boundary of the site.

The site working hours are 0800-1800 Monday to Friday and 0800-1300 on Saturday.

### Project Overview

Countryside Partnerships will deliver the regeneration in partnership with Kingston Council.

The overall regeneration includes the delivery of 2,170 new homes (including 767 council rent homes and 154 new intermediate homes), a new community centre, office and retail space, car parking and cycle storage spaces and landscaping and transport improvements.

Phase 1 comprises 452 of these new homes (including 150 council rent homes and 15 shared equity homes) and the new community centre and office space.
